



## **Marlin Cano Kellogg Advanced Management Education Program 2018 July 16-20, 2018**

The Florida State Minority Supplier Development Council and the National Minority Supplier Development Council are pleased to announce that the Marlin Cano Kellogg Advanced Management Education Program will be held July 16-20, 2018 at the Kellogg School of Management at the James L. Allen Center in the heart of Northwestern University's Evanston campus.

The FSMSDC will award one full and one partial scholarship to attend the program. Companies submitting an application for consideration for the scholarship must meet the following criteria:

- MBE candidate must be currently NMSDC certified by an NMSDC affiliate council.
- The MBE must be in business for at least three years.
- Manufacturers and distribution firms must have minimum sales of \$5 million.
- Service firms must have minimum sales of \$3 million.
- The AMEP program is designed specifically for NMSDC-certified CEOs/owners of the firm.
- MBEs must be recommended by an NMSDC national corporate member familiar with the applicant's capabilities; (or a local member) in conjunction with an affiliate council.
