**Florida State Minority Supplier Development Council to Operate  
Miami MBDA Business Center to Help Minority Businesses Grow Exponentially**

**Center Open House to be held July 7<sup>th</sup>**

**MIAMI (June 30, 2016)** — The Florida State Minority Supplier Development Council (FSMSDC) is the new operator of the U.S. Department of Commerce Miami Minority Business Development Agency (MBDA) Business Center, serving southern Florida. On July 7, the Center will host an open house from 5:30 p.m.–8:00 p.m. The public is invited to learn more about the Center's services during the open house. The Center's goal is to help minority-owned firms create jobs, develop their businesses and compete in the global economy.

Companies that are 51% owned or controlled by African Americans, Hispanic Americans, American Asians and Pacific Islanders, Native Americans (including Alaska Natives, Alaska Native Corporations and Tribal entities), Asian Indian Americans and Hasidic Jewish Americans are eligible for services from the Center. Federal appropriations subsidize the services the Miami MBDA Business Center provides to clients. Client fees, which are based on the service provided and the client's gross sales, will start at \$10 an hour.

The Center will help minority firms grow by providing access to capital, technical expertise, advanced business consulting resources and innovative management services. In addition, the center's Business Resource Lab will offer workshops and seminars, a computer lab and a business library. Annually, the goal of the Miami MBDA Business Center will be to help minority companies garner more than \$111 million in procurement contracts and financial transactions.

Since 2009, MBDA Business Centers across the nation have helped minority firms gain access to more than \$31 billion in capital and contracts, while creating and retaining nearly 142,000 jobs. The Business Centers are integral to fostering greater economic vitality across the U.S.
